



Under the Personal Data Protection Law No. 6698 Information Notice for Individuals Receiving Products or Services

A. Purpose and Scope of the Information Notice

UYSALLAR PETROL TURİZM TEKSTİL GIDA NAKLİYAT SANAYİ VE TİCARET A.Ş. ("**Company** or "**UYSALLAR**") attaches great importance to the processing and storage of your personal data in accordance with the Law on the Protection of Personal Data No. 6698 ("**Law**") and ensures the security of your personal data with great sensitivity.

We are the "*data controller*" in relation to the personal data we process within the scope of the Law, in other words, in relation to the relevant individuals whose personal data is processed. We would like to inform you with this disclosure text about the collection and processing of your personal data, our purposes, our methods of processing, and your rights under the Law.

This disclosure statement is provided in accordance with Article 10 of the Law, titled "*Data Controller's Disclosure Obligation*"; It has been prepared to inform you in the most transparent manner about our identity as the data controller, the method and legal basis for collecting your personal data, the purpose for which this data will be processed, to whom and for what purpose it may be transferred, the data processing period, and your rights listed in Article 11 of the Law. The explanations provided in the text regarding your personal data also cover information about your special category personal data.

B. Your Personal Data, Method of Collection of Your Personal Data, and Legal Basis

Your personal data may be collected through forms, either automatically or non-automatically, provided that it is part of computer systems and data recording systems using fully or partially automated methods. Your personal data will be stored in physical and digital environments, created and updated for as long as your relationship with the Company continues. Your personal data is processed by the Company based on the legal grounds set forth in Article 5, Paragraph 2 of the Law, namely: "*a) It is explicitly provided for by law, c) It is necessary for the establishment or performance of a contract, provided that it is directly related to the contract and the processing of personal data belonging to the parties to the contract, ç) It is necessary for the data controller to fulfill its legal obligations, f) necessary for the legitimate interests of the data controller, it does not harm the fundamental rights and freedoms of the data subject*" Accordingly, the purposes of processing your personal data are as follows:

C. Transfer of Your Personal Data

In accordance with the Law and relevant legislation, by ensuring that all necessary technical and administrative measures are taken to ensure an appropriate level of security, your personal data may be transferred to authorized public institutions and organizations and private legal entities, within the scope of the purposes specified above and limited to the purposes of the request, in accordance with the personal data processing conditions specified in Article 8 of the Law. Your personal data will not be transferred abroad. However, if you are located abroad, your personal data will be considered to have been transferred abroad.

D. Data Processing and Retention Period

Your personal data will be processed in accordance with the data processing and limitation periods set forth in all relevant laws and other legal regulations applicable to the Company and its affiliated centers and units, limited to the purposes specified in this Disclosure Statement. In the event of any changes to the data processing periods in the laws, the newly determined periods will apply.

In accordance with the principle of purpose limitation, your personal data will be stored for 10 years from the termination of the legal relationship, in line with the Company's practices and commercial life, for the purposes explained in this Disclosure Statement. After the expiration of this period, your personal data will be deleted, destroyed, or anonymized.

E. Rights of the Data Subject

As data subjects, you have the following rights under Article 11 of the Law:

- The right to learn whether personal data is being processed,
- Request information regarding the processing of personal data,
- To learn the purpose of processing personal data and whether it is being used for its intended purpose,
- To know the third parties to whom your personal data has been transferred within or outside the country,
- Requesting the correction of personal data if it has been processed incompletely or incorrectly, and requesting that this action be communicated to third parties to whom the personal data has been transferred,
- To request the deletion or destruction of personal data when the reasons for processing no longer exist, even if the data has been processed in accordance with the law and other relevant legal provisions, and to request that this action be communicated to third parties to whom the personal data has been transferred,
- Objecting to the analysis of processed data exclusively through automated systems resulting in a decision adverse to the individual,
- You have the right to request compensation for damages incurred due to the unlawful processing of personal data.



If you wish to exercise your rights, you can always contact the Company. Claims arising from the Law will be made through the “Data Subject Request Form.” To exercise your rights mentioned above, please fill out the Data Subject Request Form available on the website <https://www.turquoisehotel.com/> with the necessary information to identify yourself and your explanations regarding the right you wish to exercise as specified in Article 11 of the Law. You can deliver a signed copy of the form in person or through a notary to the address Ölüdeniz Mahallesi, Çarşı Caddesi, No:16 Fethiye/Muğla address in person or through a notary, or electronically to the email address **info@turquoise.com.tr**, or by other methods to be determined by the Personal Data Protection Board in accordance with Article 13 of the Law.

The Company will process requests in accordance with Article 13 of the Law, free of charge, within 30 (thirty) days at the latest, depending on the nature of the request. If the request is rejected, the reason(s) for rejection will be justified in writing or electronically. The Company's contact information is provided at the end of this disclosure statement. In this context, the Company will fulfill the relevant requests if the personal data owner exercises their rights listed in Article 11 of the Law.
