

Visitor Information Notice within the Scope of Law No. 6698 on the Protection of Personal Data

A. Purpose and Scope of the Information Notice

As UYSALLAR PETROL TURİZM TEKSTİL GIDA NAKLİYAT SANAYİ VE TİCARET A.Ş. ("Company" or "Uysallar"), registered with Fethiye Trade Registry Office under MERSIS number 0385052792100035, located at Ölüdeniz Mahallesi, Çarşı Caddesi No:16 Fethiye/Muğla, we attach great importance to the processing and storage of your personal data in accordance with Law No. 6698 on the Protection of Personal Data ("Law"), and we ensure the security of your personal data with utmost sensitivity.

As the data controller regarding the personal data we process within the scope of the Law, we would like to inform you, as the data subject, about the collection, processing, purposes, methods of your personal data, and your rights arising from the Law through this information notice.

This notice has been prepared pursuant to Article 10 of the Law titled "Obligation of the Data Controller to Inform"; to transparently inform you about the identity of the data controller (us), the method and legal basis of data collection, the purposes of processing, to whom and for what purposes the data may be transferred, data retention periods, and your rights under Article 11 of the Law. Explanations in this notice also cover your special category personal data.

B. Your Personal Data, Methods of Collection, and Legal Basis

Your personal data may be collected fully or partially via non-automated means such as forms, provided that it is part of IT and data recording systems. Your personal data will be processed, created, and updated as long as your relationship with the Company continues, and stored in physical and digital environments. Your personal data is processed by the Company based on the legal grounds in Article 5/2 of the Law: "c) Disclosure by the data subject, d) Necessary for the data controller to fulfill its legal obligations, f) Necessary for legitimate interests of the data controller without harming the fundamental rights and freedoms of the data subject."

The purposes of processing your personal data are as follows:

- Execution of Emergency Management Processes
- Execution of Information Security Processes
- Execution of Audit / Ethical Activities
- Conducting Activities in Compliance with Legislation

- Ensuring Physical Premises Security
- Execution of Assignment Processes
- Tracking and Execution of Legal Affairs
- Execution of Internal Audit / Investigation / Intelligence Activities
- Execution of Communication Activities
- Execution / Supervision of Business Activities
- Execution of Business Continuity Activities
- Execution of Logistics Activities
- Execution of Customer Relationship Management Processes
- Execution of Customer Satisfaction Activities
- Organization and Event Management
- Execution of Retention and Archiving Activities
- Execution of Contractual Processes
- Tracking Requests / Complaints
- Ensuring the Security of Data Controller Operations
- Providing Information to Authorized Persons, Institutions, and Organizations
- Execution of Management Activities
- Creation and Tracking of Visitor Records

C. Transfer of Your Personal Data

Your personal data may be transferred to authorized public institutions, organizations, or private legal entities within the scope of the purposes mentioned above and within the framework of the conditions specified in Article 8 of the Law, taking all necessary technical and administrative measures to ensure an appropriate level of security. Your personal data is not transferred abroad.

D. Data Processing and Retention Period

Your personal data will be processed strictly for the purposes specified in this notice and in accordance with all applicable laws and regulations. If changes are made to the data processing periods stipulated by law, the new periods will apply. Your personal data is retained for 1 year after the termination of the legal relationship for the purposes outlined, after which it is deleted, destroyed, or anonymized.

E. Rights of the Data Subject

Under Article 11 of the Law, as the data subject, you have the following rights:

- To learn whether your personal data is processed
- To request information if your personal data has been processed

- To learn the purpose of processing and whether it is used in accordance with its purpose
- To know third parties in Turkey or abroad to whom your personal data is transferred
- To request correction if personal data is incomplete or inaccurate and to notify third parties to whom it has been transferred
- To request deletion or destruction of personal data if the reasons for processing no longer exist, and to notify third parties to whom it has been transferred
- To object to automatic analysis leading to unfavorable results for you
- To request compensation for damages arising from unlawful processing of personal data

The signed form can be submitted in person, via notary, or electronically to info@turquoisehotel.com. The Company will respond free of charge within 30 days. If rejected, reasons will be provided in writing or electronically.
